## THANK YOU SO MUCH

Thank you so much for the concern you have demonstrated to our family through cards, calls, and gifts. Many individual pastors have called to check up on Kim's progress and to let us know they are still praying, praise the Lord. We said we would try to keep you updated on Kim's condition.

So far she has had eight chemotherapy treatments. Through the supplements she is taking, Kim is fairing better than most patients. The tumors are gradually shrinking .Usually two days after the treatments she becomes nauseous but praise the Lord she can take a small tablet that they give as a free sample (otherwise they are \$100 a pill) which calms her stomach. Kim can now move around the home without the aid of her walker and is able to tackle small tasks before becoming tired. She also has been able to keep up with the receipts and mailing list in ministry. We usually do not close out till the 15<sup>th</sup> of January which allows those who wish to have a year end deduction in 2001 to get it in.

We do praise the Lord for the ladies of our home church who have been faithfully providing meals on wheels for our family. This has helped a great deal because one knows how much time is involved in shopping and cooking dinners.

### THE LIVER AND KIDNEY'S

On January 10<sup>th</sup> we traveled to Columbia, SC to a Dr. Short's office. Your financial help enabled us to cover the seven tests he is running on Kim to determine what course of action to take with her cancer which will assist her nutritionally. One test alone was \$650. In about 3 weeks, all the tests should be in and he will give us his recommendations. Dr. Short will help to reactivate Kim's immune system (which will make her body begin to fight off the Cancer) by clearing up her liver and kidney's. Please pray for God's wisdom for this doctor and His provision for the treatments. It takes about 1-1/2 hours to travel down and then she will receive intravenous. All this takes time away from home and ministry.

# NEEDING MORE TIME

Especially pray the Lord will help me to make good use of my hours at home as there are many things that still must be done. I am with Kim at her treatments 2 or 3 days a week. Once we add Dr. Short, I may be out of the office 4 days each week. Usually, I start office work after helping the children with their homework around 8 or 9 o'clock and end around 1:30am. It is quiet enough then to do things such as the radio broadcasts, answering correspondence, and preparing for the Conference in February.

We ask you to pray regarding our desire to reprint the CENT (Catholicism Explained New Testament). Currently there is only one box left on our shelf. The ministry does not have the funds to print this Bible in large enough quantities to make it affordable. This is totally in the Lord's hands. If He wants it printed, we KNOW He can provide. Just pray for His will in this matter.

### OUR MISSION IN AFRICA

While you have been so good to help us you have also been helping the ministry. We praise the Lord for those who are burdened to assist Brother Ombui in Africa. Our brother has been pledged a significant amount to meet his required support needs. When extra funds come in they are accumulating to add to his vision of a medical facility as well as a Bible college. We will be able to send them when he is ready to begin each new facet of the Ministry.
